What data do we collect?

NBO collects the following data:

- Personal identification information (Name, email address, phone number, entity information, and any information required to use our services (nbokh.com & taxkh.pro)

How do we collect your data?

You directly provide NBO with most of the data we collect. We collect data and process data when you:

- Register online or place an order for any of our products or services.
- Voluntarily complete a customer survey or provide feedback on any of our message boards or via email.
- Use or view our website via your browser's cookies.
- Interact with our newsletters

NBO may also receive your data indirectly from the following sources:

How will we use your data?

NBO collects your data so that we can:

NBO will NEVER share your data with anyone unless required by law.

How do we store your data?

NBO securely stores your data (encrypted) at:

- When you access <https://nbokh.com> – United States of America (U.S.A.)
- When you access <https://TaxKH.pro> – Asia Pacific (Singapore)

NBO will keep your email address, name, business information, or any information entered into our computer system required to operate our services (<https://TaxKH.pro>). There is no expiration of time that we will keep your data, you can cancel your subscription at any time; your data will automatically purge our system after six (6) months.

Your email and name supplied for our newsletter can be purged from our system simply by clicking the unsubscribe link at the bottom of any newsletter email you receive from us. At that time, your email will be added to a blacklist and we are forbidden you send you any additional marketing information.

You have the right at any time to stop NBO from contacting you for marketing purposes.

If you no longer wish to be contacted for marketing purposes, you can simply opt-out at the bottom of any email you receive from NBO.

What are your data protection rights?

NBO would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access - You have the right to request NBO for copies of your personal data. We charge a fee of \$50 for this service.



The right to rectification - You have the right to request that NBO correct any information you believe is inaccurate. You also have the right to request NBO to complete information you believe is incomplete.

The right to erasure- You have the right to request that NBO erase your personal data, under certain conditions.

The right to restrict processing- You have the right to request that NBO restrict the processing of your personal data, under certain conditions.

The right to object to processing- You have the right to object to NBO's processing of your personal data, under certain conditions.

The right to data portability - You have the right to request that NBO transfer the data that we have collected to another organization, or directly to you, under certain conditions.
